

Appendix A

Creating a Zip Folder Using Windows 10

- 1. You will first need to create a folder to compress. The quickest way to create a zip file is to place all of the files that you want to archive into one folder. You can place multiple files and folders into the folder that you "zip." An easy way to do this is to drag a selection box around them with the mouse pointer and to drop them into the new folder.
- 2. Right-click on the folder you want to compress/zip. Hover your cursor over the "Send to" option. This will open a new submenu. Select "Compressed (zipped) folder."




- 3. It may take a few moments to create it. A progress bar will appear as files are added.

 Once the process is complete, the zip file will appear in the same location as the original folder.
- 4. Attach the zip folder to an email like any other file.


How to Make a Zip Archive in Mac OS X

- 1. Locate the items to zip in the Mac Finder (file system).
- 2. Right-click on a file, folder, or files you want to zip.
- 3. Select "Compress Items."
- 4. Find the newly created .zip archive in the same directory.



If a single file is being zipped, the zip archive will maintain the standard file name but will append the .zip extension.

If more than one file is being zipped, the archive will be named "Archive.zip." If multiple archives are created, they will be named successively "Archive 2.zip" and so on.



This works in all versions of Mac OS X, and you can access the "Compress Item" option from a right-click with a mouse, control-click with keyboard, or two-finger click on a trackpad from your Mac.
