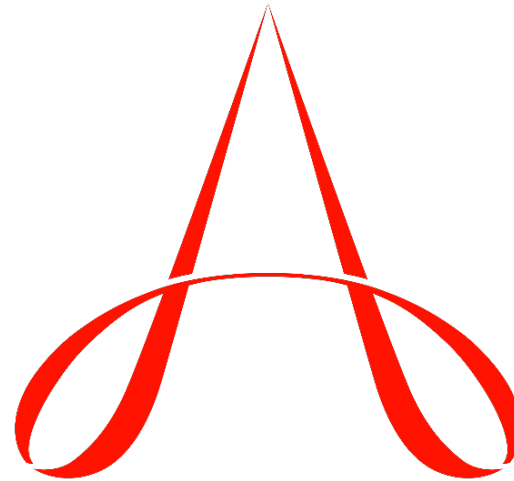

## Milestones Supplemental Guide

This document provides additional guidance and examples for the Clinical Neurophysiology Milestones. This is not designed to indicate any specific requirements for each level, but to provide insight into the thinking of the Milestone Work Group.

Included in this document is the intent of each Milestone and examples of what a Clinical Competency Committee (CCC) might expect to be observed/assessed at each level. Also included are suggested assessment models and tools for each subcompetency, references, and other useful information.

Review this guide with the CCC and faculty members. As the program develops a shared mental model of the Milestones, consider creating an individualized guide (Supplemental Guide Template available) with institution/program-specific examples, assessment tools used by the program, and curricular components.

**Patient Care 1: History**

**Overall Intent:** To obtain a focused history to guide neurophysiologic testing and management

<b>Level 3</b> <i>Obtains a focused history sufficient to guide subsequent neurophysiologic investigation</i>	<ul style="list-style-type: none"> <li>● Presents to attending and then summarizes in note: 45-year-old with numbness in her digits 1-3 on the ventral surface only, shakes her hands out at night, no weakness</li> </ul>
<b>Level 4</b> <i>Consistently obtains a focused history to guide hypothesis-driven neurophysiologic investigation</i>	<ul style="list-style-type: none"> <li>● Obtains history of fatigueable weakness along with ptosis and dysarthria efficiently</li> </ul>
<b>Level 5</b> <i>Serves as a role model in obtaining histories that guide a hypothesis-driven neurophysiologic investigation</i>	<ul style="list-style-type: none"> <li>● Teaches learners the art of the focused and efficient EMG history</li> </ul>

<b>Patient Care 2: Neurological Exam</b>	
<b>Overall Intent:</b> To perform a focused physical examination to guide neurophysiologic testing and management	
<b>Milestones</b>	<b>Examples</b>
<b>Level 1</b> <i>Performs a basic neurological exam</i>	<ul style="list-style-type: none"> <li>• Documents areas “waiter’s tip” position of arm but fails to check intrinsic finger strength</li> </ul>
<b>Level 2</b> <i>Performs, communicates, and documents a neurological exam incorporating additional relevant maneuvers</i>	<ul style="list-style-type: none"> <li>• Documents medial rotation of arm at shoulder, extension at elbow, pronation, and preserved grip strength</li> </ul>
<b>Level 3</b> <i>Performs, communicates, and documents a focused neurological examination sufficient to guide subsequent neurophysiologic investigation</i>	<ul style="list-style-type: none"> <li>• Discussed patient with likely upper trunk brachial plexus injury with some possible preserved pronation and plans for appropriate needle examination</li> </ul>
<b>Level 4</b> <i>Consistently obtains a focused neurological examination to guide hypothesis-driven neurophysiologic investigation</i>	<ul style="list-style-type: none"> <li>• Efficiently examines patients with several different complaints and uses this to guide the appropriate neurophysiologic investigation</li> </ul>
<b>Level 5</b> <i>Serves as a role model in performing a focused neurological examination to guide hypothesis-driven neurophysiologic investigation</i>	<ul style="list-style-type: none"> <li>• In a patient with reported right upper extremity weakness, teaches others to focus on the affected extremity with comparison only as needed on the left and minimal examination of the lower extremities unless a more generalized process is suspected</li> </ul>

<b>Patient Care 3: Electroencephalogram (EEG)</b>	
<b>Overall Intent:</b> To interpret and report EEG findings	
<b>Milestones</b>	<b>Examples</b>
<p><b>Level 1</b> <i>Describes normal EEG features of awake and sleep states and common EEG artifacts</i></p> <p><i>Identifies the elements of a routine EEG report</i></p>	<ul style="list-style-type: none"> <li>● Describes the posterior dominant rhythm and sleep/wake states</li> <li>● Describes eye blink, movement, and muscle artifacts</li> <li>● Uses terminology such as montages, amplitudes, frequencies, and epileptiform abnormalities</li> </ul>
<p><b>Level 2</b> <i>Interprets common EEG abnormalities</i></p> <p><i>Generates a routine normal EEG report</i></p>	<ul style="list-style-type: none"> <li>● Describes generalized slowing</li> <li>● Describes generalized spike-wave discharges</li> <li>● Uses terminology to generate a normal report including technical description, background, activations, and abnormalities</li> </ul>
<p><b>Level 3</b> <i>Interprets common normal variants and abnormal EEG patterns</i></p> <p><i>Generates an abnormal EEG report</i></p>	<ul style="list-style-type: none"> <li>● Describes positive occipital sharp transients of sleep (POSTS)</li> <li>● Describes lambda waves and lateral rectus spikes</li> <li>● Describes focal slowing, focal spikes, and focal status epilepticus</li> <li>● Uses the above to generate an abnormal EEG report with detailed description of the location, frequency, and clinical significance of the abnormalities</li> </ul>
<p><b>Level 4</b> <i>Efficiently interprets EEG findings, including uncommon normal variants and abnormal EEG patterns</i></p> <p><i>Efficiently generates normal and complex reports of continuous video EEG</i></p>	<ul style="list-style-type: none"> <li>● Describes 14 and 6 Hz positive bursts, wicket spikes, and rhythmic midtemporal theta</li> <li>● Describes paroxysmal fast activity, eye closure sensitivity, and notched delta</li> <li>● Uses Salzberg criteria to describe non-convulsive status epilepticus</li> <li>● Writes multiple complete continuous EEG reports describing background features, abnormalities, seizures, and communicate the clinical relevance of those findings</li> <li>● Uses American Clinical Neurophysiology Society’s guideline for the EEG determination of suspected cerebral death</li> </ul>
<p><b>Level 5</b> <i>Mentors others in interpreting EEG findings in children and adults</i></p> <p><i>Utilizes advanced analytic techniques to efficiently and accurately generate reports on continuous video EEG studies</i></p>	<ul style="list-style-type: none"> <li>● Uses quantitative EEG and computer assisted analysis of EEG to review trends and patterns in ICU EEG studies</li> <li>● Uses computer assisted analysis of EEG to assess seizure burden</li> </ul>

Overall Intent: To perform and interpret NCS	
Milestones	Examples
<p><b>Level 1</b> <i>Applies principles of electrical safety to the performance of NCS</i></p> <p><i>Identifies the elements of a routine NCS report</i></p>	<ul style="list-style-type: none"> <li>● Places the ground electrode</li> <li>● Identifies sensory and motor conduction studies</li> </ul>
<p><b>Level 2</b> <i>Performs common motor and sensory NCS and late responses</i></p> <p><i>Interprets common motor and sensory abnormalities and generates a report</i></p>	<ul style="list-style-type: none"> <li>● Independently perform routine peroneal, tibial motor, and sural sensory nerves.</li> <li>● Identifies moderate carpal tunnel syndrome.</li> </ul>
<p><b>Level 3</b> <i>Performs neuromuscular junction testing</i></p> <p><i>Interprets uncommon motor and sensory abnormalities, as well as common anatomical variants in the interpretation of NCS and generates a report</i></p>	<ul style="list-style-type: none"> <li>● Performs a repetitive stimulation study</li> <li>● Identifies a normal variant such as a Martin Gruber anastomosis of the ulnar nerve.</li> </ul>
<p><b>Level 4</b> <i>Performs cranial nerve testing uncommon motor and sensory NCS</i></p> <p><i>Efficiently interprets and generates a detailed report of complex nerve conduction study findings</i></p>	<ul style="list-style-type: none"> <li>● Performs blink reflex testing</li> <li>● Identifies and reports an ALS case</li> </ul>
<p><b>Level 5</b> <i>Performs special NCS procedures (e.g., autonomic testing)</i></p> <p><i>Mentor others in the interpretation and documentation of NCS</i></p>	<ul style="list-style-type: none"> <li>● Performs single fiber EMG</li> <li>● Teaches session on NCS and documentation</li> </ul>

**Overall Intent:** To plan, perform, and interpret a needle EMG

Milestones	Examples
<p><b>Level 1</b> <i>Identifies technical artifacts in the interpretation of EMG</i></p> <p><i>Applies knowledge of nerve and muscle anatomy in the performance of EMG and applies principles of electrical safety to the performance of EMG</i></p> <p><i>Identifies the elements of an EMG report</i></p>	<ul style="list-style-type: none"> <li>● Identifies 60 Hz abnormality</li> <li>● Places ground electrode</li> <li>● Identifies the APB is a median innervated muscle from C8/T1</li> <li>● Identifies needle exam portion of the report</li> </ul>
<p><b>Level 2</b> <i>Formulates basic EMG plan for common clinical presentations</i></p> <p><i>Performs and interprets EMG of commonly sampled muscles, recognizing common EMG findings</i></p> <p><i>Generates a normal report for an EMG/NCS study</i></p>	<ul style="list-style-type: none"> <li>● Identifies that numbness and tingling into the first three digits into the hand will require sensory and motor testing of the median and ulnar nerve with obvious attention to the median nerve along with needle examination of intrinsic hand muscles (APB)</li> <li>● APB denervation would show fibrillations or positive sharp waves</li> <li>● Completes a report with sensory, motor, EMG, interpretation, and conclusion that the patient has normal findings</li> </ul>
<p><b>Level 3</b> <i>Formulates EMG plan for uncommon/atypical clinical presentations</i></p> <p><i>Performs and interprets EMG of uncommonly sampled muscles, including cranial nerve innervated muscles</i></p> <p><i>Generates a report for common normal and abnormal findings of an EMG/NCS study</i></p>	<ul style="list-style-type: none"> <li>● Forms a plan for the muscles to be testing in a patient with pain in his shoulder and proximal arm; needle testing needs to be performed for a brachial plexopathy versus a torn rotator cuff</li> <li>● Performs tongue EMG for ALS</li> <li>● Completes a report with sensory, motor, EMG, interpretation, and conclusion that the patient has a median neuropathy</li> <li>● Completes a report with sensory, motor, EMG, interpretation, and conclusion that the patient has a median neuropathy</li> </ul>
<p><b>Level 4</b> <i>Actively interprets EMG findings “in real time” and adjusts EMG plan in accordance</i></p>	<ul style="list-style-type: none"> <li>● Identifies additional muscles to be tested in a complex case with a patient that is diabetic with evidence of a peripheral neuropathy and possible radiculopathy with evidence of</li> </ul>

<p><b>Level 5</b> <i>Serves as a mentor in the planning of EMG studies</i></p> <p><i>Performs and interprets special EMG procedures</i></p> <p><i>Serves as a mentor in generation of EMG reports</i></p>	<ul style="list-style-type: none"> <li>● Assists a resident who presents a patient with neuromuscular disorder needs advanced needle testing</li> <li>● Performs single fiber EMG</li> <li>● Assists others in generation of a detailed EMG report.</li> </ul>

<p><b>Level 1</b> <i>Describes normal waveforms related to commonly performed IOM studies</i></p> <p><i>Identifies the basic elements of the IOM report</i></p>	<ul style="list-style-type: none"> <li>● Identifies normal SSEP waveforms</li> <li>● Identifies normal BAEP waveforms</li> </ul>
<p><b>Level 2</b> <i>Correlates normal waveforms with associated anatomic structures and physiologic phenomena</i></p> <p><i>Generates a basic normal IOM report</i></p> <p><i>Orders and utilizes appropriate basic procedures in patients undergoing IOM</i></p>	<ul style="list-style-type: none"> <li>● Associates BAEP waves I, III and VI with CN VIII, superior olivary nucleus and MGN, respectively</li> <li>● Formulates an appropriate monitoring plan for lumbar spinal fusion surgery</li> </ul>
<p><b>Level 3</b> <i>Interprets common normal and abnormal findings in IOM, including artifacts</i></p> <p><i>Provides timely feedback to surgeons with support and generates written report</i></p> <p><i>Orders appropriate IOM in cases of moderate complexity</i></p>	<ul style="list-style-type: none"> <li>● Associates changes in SSEP amplitudes and latency with anesthesia levels</li> <li>● Alerts surgeons of unilateral EEG attenuation and decreased faster frequencies associated with carotid clamping during carotid endarterectomy</li> </ul>
<p><b>Level 4</b> <i>Interprets uncommon findings in IOM studies</i></p> <p><i>Provides timely feedback to surgeons independently, and generates written report</i></p> <p><i>Orders and utilizes appropriate IOM in cases of high complexity</i></p>	<ul style="list-style-type: none"> <li>● Identifies unilateral EEG attenuation and decreased faster frequencies after the unclamping of during carotid endarterectomy, suggesting reperfusion injury</li> <li>● Formulates an appropriate monitoring plan for critical trauma-related cases</li> </ul>
<p><b>Level 5</b> <i>Serves as a mentor in interpretation of IOM studies</i></p>	<ul style="list-style-type: none"> <li>● Gives a lecture on IOMs to rotating students</li> </ul>

<b>Patient Care 7: Evoked Potential (EP)</b>	
<b>Overall Intent:</b> To perform, interpret, and report EP studies	
<b>Milestones</b>	<b>Examples</b>
<p><b>Level 1</b> <i>Describes normal waveforms related to commonly performed EP studies</i></p> <p><i>Identifies the basic elements of the EP study report</i></p>	<ul style="list-style-type: none"> <li>● Describes the meaning of P100 waveform of a visual EP</li> <li>● Describes the required elements of an EP study: identification, clinical information, technical data, results, description, and interpretation (including impressions and clinical correlation).</li> </ul>
<p><b>Level 2</b> <i>Describes normal waveforms related to commonly performed EP studies and correlates normal waveforms with associated anatomic structures and physiologic phenomena</i></p> <p><i>Generates a basic normal report</i></p> <p><i>Orders and utilizes appropriate basic procedures in patients undergoing EP studies</i></p>	<ul style="list-style-type: none"> <li>● Identifies the brainstem auditory evoked potential wave V as localizing to the lateral lemniscus in the midbrain</li> <li>● Identifies the P100 on visual evoked potentials</li> <li>● Identifies the N20 on somatosensory evoked potentials</li> <li>● Generates a normal SSEP report</li> <li>● Generates a normal visual evoked potential report</li> <li>● In BAEP testing, records the stimulus intensity, polarity (rarefaction, condensation, or both), and if applicable: frequency and duration of tone stimuli, masking and transducer type.</li> </ul>
<p><b>Level 3</b> <i>Interprets common findings of clinical significance associated with EP studies</i></p> <p><i>Generates a report of common abnormal EP studies</i></p> <p><i>Orders and utilizes appropriate EP studies in cases of moderate complexity</i></p>	<ul style="list-style-type: none"> <li>● Describes prolonged P100 latency and correlates this clinically to optic nerve pathology</li> <li>● Generates a visual evoked potential report of prolonged P100 latency consistent with optic neuritis</li> <li>● Discusses with a surgeon to add BAER to monitoring in a patient undergoing removal of cerebellopontine angle tumor</li> </ul>
<p><b>Level 4</b> <i>Interprets uncommon findings of clinical significance during EP studies</i></p> <p><i>Generates a report of uncommon EP studies</i></p> <p><i>Orders and utilizes appropriate EP studies in cases of high complexity</i></p>	<ul style="list-style-type: none"> <li>● Uses short latency somatosensory evoked potentials in the assessment of suspected cerebral death</li> <li>● Generates an SSEP report characteristic with brain death</li> <li>● Decides against using an SSEP to determine brain death in a patient with known critical illness neuropathy. Guides the ordering team on more applicable studies</li> </ul>

<p><i>Role models in the creation of EP reports</i></p>	<ul style="list-style-type: none"> <li>● Creates a guide to reporting evoked potentials for next year’s fellows</li> </ul>
